RULES & CONDITIONS FOR CLAIMING RACES**

- 1. ALL CLAIMS MUST BE DEPOSITED IN CLAIM BOX ONE HOUR PRIOR TO FIRST RACE SCHEDULED POST TIME.**
- 2. CLAIM FORM MUST BE PROPERLY FILL OUT.**
- 3. FUNDS FOR A CLAIM MUST BE A CASHIERS CHECK.**
- 4. SIGNED REGISTRATION PAPERS OR A TRANSFER FORM MUST BE PROVIDED ON RACE DAY.**
- 5. HORSES ENTERED IN CLAIMING RACES MUST HAVE A NEGATIVE COGGINS TEST WITHIN 12 MONTHS OF RACE DATE. FAILURE TO PROVIDE DOCUMENTATION OF THIS WILL RESULT IN THE HORSE BEING SCRATCHED.**
- 6. SCRATCHED HORSES FROM CLAIMING RACES MAY BE CLAIMED.**
- 7. PERSONS WISHING TO CLAIM A HORSE MUST BE IHHA AND USTA MEMBERS.**
- 8. ALL CLAIMING RACES WITH NO ALLOWANCE FOR AGE OR SEX.**
- 9. THE TOTAL FUNDS TOTAL FUNDED NECESSARY TO CLAIM A HORSE ARE:**
